Lt. Hudson Martin (John James.⁹, Henry¹⁰, Roger¹¹) was born on 3 Jul 1752 in Albemarle, Virginia.

Paymaster Hudson Martin of Nelson County, Virginia. Application for pension made. He was appointed Ensign 3/11/1776 and Lt. 7/26/1776. He was wagon master at Lancaster, Pa. in 1778 but resigned in Apr. of the same year. He was appointed by Gov. Patrick Henry, Paymaster to the Regiment of Guards, commanded by Col. Francis Taylor from 1/1779 to 8/1781, at which time the regiment

was disbanded. They were stationed at Albemarle to guard the prisoners captured 10/1777, at the surrender of Gen. Burgoyne, at Saratoga.

He settled his accounts as paymaster from which appears that he was in service from 1/22/1779 to 8/1/1781 upward of two years and six months. No reason to believe he resigned his commission as Lt.; if he was in service, as Lt., for 6 months (which the amount of pay to him renders probable), before he acted as paymaster he is entitled to land. Under the circumstances, he out to be entitled to land for three years.

Jane Walker Lewis (Col. Nicholas⁹, Col. Robert¹⁰, Col. John II¹¹, Maj. John¹², John Lewis¹³ Pricket, Lewis Rycketts (ap¹⁴ Richard), Richard¹⁵ Lewis_) was born in Saline County, Missouri July 6, 1757 the was eldest daughter of Col. Nicholas Lewis and Mary (Capt. Molly Walker).

The family settled southwest of Charlottesville, Va. in the counties of Albemarle and Nelson, near Rockfish Gap & River.

Lt. Hudson Martin died 28 Nov 1830 in Rockfish, Nelson Co., Virginia/Fabers Mills, Amherst Co., Virginia, at 78 years of age. Hudson Martin's will was executed 6/23/1828, and is on record in Nelson Co. Va., and a copy of it is on file in the Pension Office at Washington, D.C. Judging from the bequests of real estate, slaves and money to the several members of his family, he must have been a man of considerable wealth and influence in the county in which he resided. The executors to his estate gave bonds to the amount of 20,000 pounds. (Widow file No. 7394).

Jane Walker Lewis died August 15, 1838 in Albermarle County, Virginia, at 81 years of age.
