Johann Henrich Heinemann (birth date unknown) . Various theories and allegations have been advanced as to the origin of the name Heinemann. Several Heineman families in America claim their family name was formerly Heine, and that “mann” was added for some reason. Another claims their name was originally Heydt, or von der Heydt, and first evolved into Heydtmann and thence to Heynemann and finally Heineman.

One member of a very old family bearing the name claims its origin as Hindmann or Hintermann. This denoted not an inferior person, but one second in importance and a backer of Royalty.

Several other families advanced the idea that the name formerly was used to indicate “Workers in Wood.” Although the study of the language casts doubt on that, it is a remarkable fact that the trend of family occupation and business shows a predominance of members engaged in business directly or indirectly related to timber, wood, and work therein.

This is known, regardless of changes in families within the last century or two, the name dates back centuries before America was settled or even discovered. In Westphalian records the old Latin documents show reference to Heinemann. In the present descendant line, the name was changed from the original spelling of “Heinemann” to “Heineman” dropping the last “n” during WWI.

Holbæk is first mentioned in official documents in Absalon's letter of June 8, 1199, in which he granted the majority of his estates to Sorø Klosterkirke in Sorø. It was called Holbækgaard, a larger farm belonging to a nobleman, around which the city would eventually evolve.

The records of this office show that one Wm. Duggan (name also borne as Wm. Duggin) enlisted 1/20/1777 in Capt. Vanse's Co. 12th Vir. Regiment to serve during the

Revolutionary War; was transferred about 6/1778 to Col. James Woods' Co., 4th, 8th & 12th Va. Regiments, and about 10.1778 to Capt. Wm. Vanse's co. 8th. Va. Regiment, commanded by Col. James Woods. His name last appears on the Co. muster roll for 11/1779, dated at camp near Morristown 12/9/1779 without special remark relative to his service. Nothing further to him has been found on record.

Served through Revolutionary War and after the war married Elizabeth Perkins, daughter of William Perkins, of a well-known South Carolina family of that name. He was a member of Episcopal Church, a devout Christian. On the maternal side, the great-grandfather, Daniel White, also a Revolutionary soldier and was present at surrender of Lord Cornwallis. His maternal grandfather was Thomas Jackson, a cousin of General Andrew Jackson. Mr Duggins received a good education and from 1858 to 1860 was engaged as a salesman in a store in Cambridge. In spring 1861, he enlisted in Capt. Edward Brown's Company, M.S.G., then in Confederate army until close of war. In 3/1866 he married Miss Annie Pulliam, daughter of John C. and Catherine J.

Lewis H. Duggins, deceased, was a millwright by trade, and was born in Louisa county, Virginis, January 5, 1808,

where he was raised on a farm. In 1838 he came to Saline county, and worked at his trade here for some years. In 1849 he took the gold fever and went to California, where he was successful in mining, and returned to this county in 1853; located in Cambridge, and engaged in merchandising, which he continued till the breaking out of the war. He then sold out and went to farming, at which he continued until his death, September 19, 1875. He was a member of the Methodist Church since he was a boy, and honest and conscientious in all his dealing. He began life with nothing, and accumulated quite a fortune, nearly all of which he lost in the war. He was first married soon after he came to Missouri to Miss Hester A. Goodrich, and had two children. She died in 1847. Was married again in 1860, to Miss Ann Eliza Doak, daughter of Col. Samuel Doak, of this county, formerly of Augusta county, Virginia. By this union there are two children: Lizzie Lee and Mary Blanche.

11. Thomas Crutchfield Duggins was born in Louisa County, VA March 10, 1810. Thomas died January 16, 1880 in Marshall, Missouri, at 69 years of age. His body was interred Mt. Carmel, MO. He married Elizabeth White Jackson October 30, 1833.

The Duggins family arrived in Saline County, Missouri in 1838 when Thomas Crutchfield Duggins of Louisa County, Virginia and his wife Elizabeth White Jackson, joined in the westward settlement of Missouri. Thomas' skills in surveying were utilized when he was appointed to assist in the survey of the "Platte Purchase", now Platte and Buchanan Counties. A letter to his parents indicated that his surveying, for which he received three dollars per mile, "...that there are Indians near (me) both by day and by night and (I) cannot get to see them." He described some of the land, "...held prospect only for the panther, the bear, the wildcat, and the wolf." Thomas established his family on a farm near Slater and was elected County Surveyor in 1843. He held this post, with the exception of the war years, until the 1870's. Two of the Duggins seven children survived and remained in Saline County; William Thomas a farmer in the Cambridge-Slater area, who served with the Confederacy and later married Annie Pulliam of Saline County; Dean Dryden Duggins who was educated at Central College and read the law with Judge Thomas Shackelford in Glasgow.

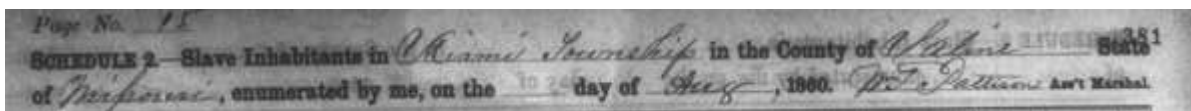
The 1850 Slave Inhabitants Census for Saline County, MO indicate that Thomas Duggins owned three black slaves – one female, 27 years of age, one 9 year-old male and one 7 year-old female. They may represent a mother and two children.

The 1860 Slave Inhabitants Census for Saline County, MO suggests that the female and an additional black male (then age 23) may have had two additional children – one female in ca. 1857 and one female in ca. 1859. All were living in one slave house.

In his early youth he went to N.Y. City and while there was engaged in the wholesale drug business. He remained there several years and then removed to Ky. Where he united with the Baptist church and was immersed in the Ohio river.

In 1857 or 1858 he came to Mo. And located near Cambridge, where he resided continuously until his death.

2. Nixon M. Hawkins was born April 3, 1837 and died December 10, 1878. He is interred at Good Hope Cemetery, Cambridge, MO.



3. **Artemisia Ellen Hawkins** was born Aug. 19, 1845 in Saline Co. MO

Nicholas Hawkins died March 26, 1852 and is buried at Good Hope Cemetery, Cambridge, MO



Frances H. Hawkins died April 6, 1894 and is buried in Good Hope Cemetery, Cambridge, MO



Thurston Dickinson was born in Goochland County, Virginia 1780. He married **Mary Walker Martin** (born in Albermarle County, Virginia June 13, 1787) daughter of Lt. Hudson Martin and Jane Meriwether Lewis.

They had the following children:

1. Mildred Martin^e Dickinson. She married Mr. Rhodes
2. Hudson Martin Dickinson. Married and had 11 children.
3. **Frances Elizabeth Dickinson** was born January 11, 1808.
4. Elizabeth Marshall Duggins (1828-1904)

Thurston died in Fayette County, Maryland. Mary died November 28, 1814 in Saline County, Missouri, at 27 years of age.

Joshua Clyburn was born circa 1758 and died circa 1799. The first known recorded date for Joshua Clyburn is 1778, the date of his first land deed in Robeson County, which was then Bladen County, North Carolina. Spelling was not strictly followed at the time, even within the same document, but in identifying him here we have chosen to use the spelling of "Clyburn" for Joshua since that was the spelling used in the 1790 census.

Thanks to a DNA study conducted in conjunction with The National Society of the Claiborne Family Descendants and Family Tree DNA, they have been able to determine with a high degree of probability that Joshua descended from an

English family originating in historic Westmorland County in northern England (Westmorland is now part of Cumbria). The DNA study also helped put to rest years of speculation that Joshua descended from Colonel William Claiborne, Secretary of the Colony of Virginia; Joshua did *not* descend from William and the two appear to have no connections.

Joshua's apparent ancestral family from Westmorland County was an "ancient and knightly family" whose name was derived from the manor of "Cliburn". The family held the manor for nearly 400 years, from early in the thirteenth century to the middle of the seventeenth century. Cliburn Hall stands today, near the small village of Cliburn, six miles southeast of the town of Penrith, in historic Westmorland County, high above the rivulet Leith. The grand old stone building with a three story "pele tower" was erected in the fourteenth century by Robert de Cliburn, knight of the shire for Westmorland. Two hundred years later, the original structure was altered and enlarged by Richard Cleburne. On the Tudor estate was a large deer park, beautiful pleasure grounds, and terraced walks.



Across the road from Cliburn Hall is the Parish Church of Cliburn, a Norman structure built in the twelfth century.

(Cliburn means "stream by the bank"), and his descendants held the manor by "knight service." In about the middle of the seventeenth century, following the English reconquest of Ireland, William Cleburne, the second son of Thomas the fourteenth Lord of the manor of Cliburne, went to the City of Kilkenny, Ireland. Kinsmen had preceded him but it was William that acquired castles, towns, and lands. Therefore Cliburnes (and variants of the name) resided in both Westmorland and Ireland for a time.

Although the DNA studies make it virtually certain that Joshua originated from this family, it is not entirely clear how he arrived in North Carolina. It is possible that Joshua's family came to America directly from Westmorland. On the other hand, family tradition among some ancestors is that Joshua's family came from Ireland,

and it is possible that he descended from a Westmorland group that settled in Ireland before crossing the ocean.

Although Joshua's ancient origins are known, the identity of his parents are largely speculation. Nevertheless, a number of people have posited theories about them. According to historian Angela Clyburn's hypothesis, Joshua descended from a John Clyburn of Henrico and Brunswick Counties, Virginia and later Bladen County, North Carolina. This John Clyburn was born about 1712 and in about 1732 he married a Jean Clarke in Brunswick County. Jean was the daughter of John's nearby neighbor Robert Clarke. John served in the Militia in The French and Indian War with the rank of Private in Colonial Granville County, North Carolina, and died on 7 March 1785 in Bladen County, North Carolina.

Angela believes that Joshua Clyburn was John and Jean's son in large part because the three lived in the same vicinity, and their birth and marriage dates tally. John's father (also named John) had a step-father named Joshua Stapp and this may have been Joshua's namesake. DNA evidence from the study done in conjunction with the National Society of the Claiborne Family Descendants makes it certain that Joshua's descendants are closely linked genetically to Cliburns/Clyburns arising out of Henrico County, adding further weight to Angela's theory.

It is important to distinguish the John Clyburn discussed above from a John Cliborn of Dale Parish, Chesterfield Co., Virginia, who was also born in about 1712 (commonly referred to as "John of Dale Parish") and is credited with having a progeny numbering over a million. A brief history of John of Dale Parish's lineage can be found here. Various sources list John of Dale Parish having seven children [7], and none of them named Joshua. Nevertheless, DNA evidence indicates both John Clyburn and John of Dale Parish were closely related and likely had a common ancestor.

In her later years historian Harriette Threlkeld appeared to believe Joshua came from Ireland, largely because family tradition (especially in the Arkansas branch) had held the same. Harriette discovered a Petition of Naturalization from Ireland for a 'Joshua Clibborn' dated 1796 (the naturalization papers are on file with the Philadelphia Department of Records). For reasons not entirely clear, she suspected they were the same person. But Joshua was in North Carolina from 1778 to about 1799 so it is unlikely he would have been naturalized in Philadelphia in 1796. Nevertheless, even if Joshua descended from John Clyburn, it is still possible that his ancestors lived in Ireland for a time.

If Joshua was at least twenty years old when he got his first grant of land in North Carolina, he would have been born in 1758. Joshua does not appear in the 1800 census and so we believe he died shortly before then. Assuming he was born in 1738 and died about 1799, he would have been 61. His wife's name was Sarah. She was still in Robeson County as late as 1835 from evidence on a deed.

Joshua was listed in the first census of the United States in 1790, of Robeson County, North Carolina under the following entry:

Joshua Clyburn

- 1 free white male 16 years of age and upwards, including head of family
- 2 free white males under 16
- 4 free white females, including heads of families

Joshua does not appear on the 1800 census so it is presumed that he died shortly before that year and, following his death, the family struggled to pay taxes. In a deed dated 18 November 1802, "Joshua Clibourn Heirs," represented by the sheriff of the county, sold 339 acres of Joshua's land for taxes to Matthew James. Notice of the sheriff's sale appeared in at least three issues of the *Raleigh Register*, suggesting others in the area were also hard pressed for money. The land was ultimately sold for only two pounds, sixteen shillings and ten pence (about two and a half English pounds). 25 acres of the entire plot had had taxes paid on it and was not sold; this area may have been their homestead.

The last of Joshua's land was apparently sold by Ephraim in 1811. That year "Ephraim Clibourn" of Knox County, Tennessee, sold the land he had been deeded in 1794 (the descriptions tally) to Matthew Jones for 50 pounds, the same man who bought Joshua's land in 1802 to help pay taxes. This transaction was two years after Ephraim's marriage in Knox County in 1809, so by this time Ephraim had already left North Carolina.

Some research suggests that Joshua and Sarah had as many as five children:

- 1) James Sarah was born in about 1785, according to the 1850 census, and thus she was about three years older than her brother Ephraim. In that same census she gave South Carolina as her place of birth, but her daughter Jane said in the 1880 census that her parents were born in North Carolina. Given that the present border was not set until 1815, the discrepancy can be explained. Sally married James Brown, who was born in Ireland in 1777. By 1850, Sarah was 65 years old and was living in Illinois with her daughter Jane, so presumably James had deceased. Sarah is presumed to have died by 1853. Together Sarah and James would have at least four children:
 - a) Joshua Brown was born in 1801 in South Carolina. In the 1850 census of Jefferson County, Illinois he is listed as married with eight children.
 - b) Nancy Brown was born in 1805 in Tennessee.
 - c) William Brown was born in 1808 in Tennessee and married Elizabeth Mcmeens in 1830. He is alleged to have died in 1865 in Jefferson County, Illinois. Together the couple had twelve children.
 - d) Jane Brown was born in 1814 in Smith, Tennessee. She married Marcus D. Bruce (born in 1813) and by 1850 the couple was living in Jefferson County, Illinois. Both were listed in the 1880 census. Marcus died on 6 April 1887 and

Jane followed on 21 December 1892. Together they had ten children.

- 2) Rhoda (or "Roda") Clyburn was born on 8 March 1785 in Bladen, North Carolina [41]. On 23 November 1801 she married Rev. Elias Atkerson, a Methodist minister who was born on 15 December 1781 in Bedford, Virginia. Their wedding occurred in Amelia, Virginia but eventually the couple moved to Simpson County, Kentucky. Rhoda died on 15 July 1854 and is buried at Blackjack Cemetery near Franklin, Kentucky. Elias followed in death on 5 September 1855 and is buried near Rhoda [42]. Rhoda and Elias had at least eight children together, including five sons. Four of those sons fought in the Civil War (two for the Union and two for the Confederacy). None of the four returned after the Civil War to Tennessee or Kentucky. The fifth son, George (born in 1818), moved to live with his father in Simpson County, Kentucky.
- 3) Mary "Polly" Clyburn is alleged to have been born in 1787 in Robeson County, North Carolina and died on 16 May 1876 in Franklin, Virginia.
- 4) **Ephraim Claybourn** was born on 7 December 1788 in North Carolina and died on 11 May 1850.



Simeon Pendleton Crumb (Simeon F.⁸, William⁹, William C.¹⁰, Daniel¹¹) was born March 22, 1788 in Westerly, Washington County, Rhode Island, died after April 1, 1828, Milton, Chittenden CO, Vermont. He married,

Mary Ann Fitzgerald Shaw was born 1786. They had the following child:

She married (?) Shaw. They had the following children:

1. Mary Jane (1827-1891)
2. Mary (1830-1925)

Mary Ann Fitzgerald Shaw died Jul 13, 1876 in Fairview, PA. She is buried in the Fairview Cemetery, Plot b.
